



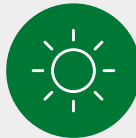

DIRECTIONS FOR USE

SPREAD PRODUCT

Apply product to dry foliage. Fill and adjust your spreader to the recommended rate using the spreader settings table to the right. For even application, be sure to walk at a steady rate, slightly overlapping each pass. For best results, reapply every 4 weeks. Dependent on local weather or soil conditions, applications may be made on shorter intervals.

Apply only to actively growing turf. Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn and sweep any product that lands on the driveway, sidewalk or street, back onto your lawn. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices. Check with your county or city government to determine if there are local regulations for fertilizer use.

IMPORTANT! CLEAN-UP

This product contains micronutrient iron for extra greening and to help prevent iron deficiency. Iron may stain concrete and other surfaces. Misapplied product to these surfaces should be removed promptly by sweeping or blowing. DO NOT WASH OFF WITH WATER.

WATER IN

To help move the particles into soil more quickly, water with a minimum of 0.2 inches.

SPREADER SETTINGS

This bag is designed to deliver 8.0 lbs of product per 1,000 sq. ft. for a coverage of 2,250 sq. ft. Settings are based on an average walking speed of 3 mph. Reduce setting for a lower speed; raise setting for a higher speed. Do not apply with drop-type or hand-held spreader.
