GENERAL INFORMATION: Foltec LQ Classic 18-3-6 with Micros is a liquid applied high nitrogen (N) turfgrass fertilizer containing micronutrients. This formula contains slow release N from urea triazione, providing both quick and sustained turfgrass feeding. Apply only to actively growing turf. Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn, and sweep any product that lands in the driveway, sidewalk, or street, back onto your lawn. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices. Check with your county or city government to determine if there are local regulations for fertilizer use.

DIRECTIONS FOR USE: This product can be used with mechanical sprayers, ride-on sprayers and fertigation systems. Spray 6-12 ounces of this product with 1-2 gallons of water per 1000 sq. ft. Apply the solution uniformly over the total lawn area every 21-28 days. For best results water thoroughly after application. Rates per 1000 sq. ft. should not exceed 1 lb actual nitrogen per 1,000 square feet in a single application and usually not exceed 4 lbs. actual nitrogen total in a growing season. Single application rates during hot months should not exceed 1 lb N per 1,000 square feet of lawn and should always be irrigated following application. **Do not allow to freeze. Always jar test for compatibility.**

NITROGEN NOTICE: For those states with nitrogen application restrictions, including but not limited to MD, NH, NJ, and VA, do not apply more than 0.7 lbs Nitrogen per 1,000 sq. ft.

PHOSPHATE NOTICE: This lawn/turf fertilizer contains phosphorus and is only for nonagricultural use on (i) turf during its first growing season, (ii) on turf areas being repaired or renovated, and (iii) on turf where a soil test performed within the last 3 years indicates a phosphorus deficiency. In Maryland, the laboratory must be identified under 8-803.7 of the Agricultural Article, Annotated Code of Maryland. This fertilizer is not for the routine maintenance of turf.
