### WEED RESISTANCE MANAGEMENT

For resistance management, this product is a Group 3 herbicide. Any weed population may contain or develop plants naturally resistant to this product and other Group 3 herbicides. The resistant biotypes may dominate the weed population if these herbicides are used repeatedly in the same field. Appropriate resistance management strategies should be followed.

To delay herbicide resistance take one or more of the following steps:

- Rotate the use of this product or other Group 3 herbicides within a growing season sequence or among growing seasons with different herbicide groups that control the same weeds in a field.
- Use tank mixtures with herbicide from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer.
- Adopt an integrated weed-management program for herbicide use that includes scouting and uses historical information related to herbicide use and crop rotation, and that considers tillage (or other mechanical control methods), cultural (e.g., higher crop seeding rates; precision fertilizer application method and timing to favor the crop and not the weeds), biological (weed-competitive crops or varieties) and other management practices.
- Scout before and after herbicide application to monitor weed populations for early signs of resistance development. Indicators of possible herbicide resistance include: (1) failure to control a weed species normally controlled by the herbicide at the dose applied, especially if control is achieved on adjacent weeds; (2) a spreading patch of non-controlled plants of a particular weed species; (3) surviving plants mixed with controlled individuals of the same species. If resistance is suspected, prevent weed seed production in the affected area by an alternative herbicide from a different group or by a mechanical method such as hoeing or tillage. Prevent movement of resistant weed seeds to other fields

- by cleaning harvesting and tillage equipment when moving between fields and planting clean seed.
- If a weed pest population continues to progress after treatment with this product, discontinue use of this product and switch to another management strategy or herbicide with a different mode of action, if available.

### GENERAL INFORMATION

This product is a preemergence herbicide that provides residual control of many grass and broadleaf weeds in turfgrasses. This product controls susceptible weeds by inhibiting weed seeds germination and root development. Most effective weed control will be obtained when this product is activated by at least 0.5 inch of rainfall or irrigation, or with shallow (1 to 2 inches) incorporation, prior to weed seed germination and within 14 days following application.

### APPLICATION DIRECTIONS


Apply uniformly through suitable, calibrated application equipment.

### ESTABLISHED TURF

This product is a preemergence herbicide that, when properly applied as directed, will control certain grass and broadleaf weeds in established turf grasses and lawns. The maximum amount of this product that may be applied per year is given for each turf grass species in the **Maximum Annual Rates** section of this label.

Most effective weed control in turf grasses will be obtained when this product is activated by at least 0.5 inch of rainfall or irrigation prior to weed seed germination and within 14 days following application. See the map below for approximate crabgrass seed germination dates.

### Use Restrictions and Precautions

The following precautions apply to the use of this product in turf grasses and lawns:

- Application of this product may thin emerged annual bluegrass and newly overseeded grasses.
- Do not apply to over seeded turf within 60 days after seeding or until after the second mowing, whichever is longer.
- Injury to desirable seedlings is likely if this product is applied before seedling secondary roots are in the second inch of soil, not thatch plus soil.
- Do not apply to newly set sod until the following year.
- Application of this product to turf stressed by drought, low fertility, or pest damage may result in turf injury.
- Disturbing the herbicide barrier with cultural practices such as disking may result in reduced weed control.
- Do not apply this product to putting greens or areas where dichondra, colonial bentgrass, velvet bentgrass, or annual bluegrass (*Poa annua*) are desirable species.
- Do not graze or feed livestock forage cut from areas treated with this product.
- Do not apply this product through any type of irrigation system unless otherwise instructed by this label.
- Do not apply aerially.
- Do not apply to golf course putting greens.

### Rates of Application

This product may be applied as a single application or in sequential applications to control weeds germinating throughout the year. All applications must be made prior to germination of the target weeds. This product will not control established weeds.

Maximum use rate selection should be based on turf species. The length of time of residual weed control provided by this product is related to the rate applied.

### Maximum Annual Rates

This product is recommended for use on the turf grass species listed in the following table. Do not exceed the maximum yearly rate as given in the following table:

<sup>2</sup>May be used on newly sprigged or plugged Bermudagrass at rates not to exceed 238 lb/acre or 5.4 lb/1,000 sq. ft. Newly sprigged or plugged Bermudagrass stolon rooting may be temporarily retarded. Suppression only of Foxtail, Goosegrass and Rescuegrass due to reduced product rates used in sprigging situations.

Do not apply more than 714 lbs. per acre (16.4 lbs/1,000 sq. ft.) of this product per calendar year. Use higher rates of this product to achieve higher levels of fertility and weed control for each turf type, but do not exceed the maximum application rates specified in the Maximum Annual Rates table.

### Weeds Controlled

When used at the recommended rates this product will control: Barnyardgrass; Bluegrass, Annual (*Poa annua*); Carpetweed; Chickweed, Common; Chickweed, Mouseear (from seed); Crabgrass (Large, Smooth); Crowfootgrass; Cupgrass; Woolly; Foxtails, Annual; Goosegrass<sup>1</sup>; Henbit; Itchgrass; Johnsongrass (from seed); Junglerice; Knotweed; Kochia; Lambsquarter, Common; Lovegrass; Oxalis; Panicum (Texas, Fall, Browntop); Pigweed; Purslane, Common; Pusley, Florida; Rescuegrass<sup>3</sup>; Shepherd's Purse<sup>2</sup>; Signalgrass, Broadleaf; Speedwell, Persian; Sprangletop; Spurge, Prostrate; Witchgrass; Woodsorrel, Yellow (from seed).

<sup>1</sup>In many areas a single application of 7.2 to 16.4 lbs/1,000 sq. ft. (314 to 714 lbs/A) of this product will control goosegrass. However, under heavy goosegrass pressure and/or an extended growing season, most effective weed control may be obtained by making an initial application of 7.2 to 10.9 lbs/1,000 sq. ft. (314 to 476 lbs/A) followed after 60 to 90 days by a second application at doses that would not exceed those given in the **Maximum Annual Rates Table**. Do not exceed the maximum rate for turf grass species listed in the **Maximum Annual Rates Table** above.

<sup>2</sup>Applications for this weed should be made in late summer, fall, or winter prior to germination. Do not exceed the maximum application rates specified in the Maximum Annual Rates table.

<sup>3</sup>Suppression only.

Sequential applications may be made so long as the total amount of product applied does not exceed the maximum application rates specified in the Maximum Annual Rates table. All applications must be made prior to germination of the weed seeds.

### When to Apply After Overseeding Turf

Do not apply to overseeded turf within 60 days after seeding or until after the second mowing, whichever is longer. Injury to desirable seedlings is likely if this product is applied before seedling secondary roots are in the second inch of soil, not thatch plus soil.

### When to Overseed After Application - All States\*

This product will inhibit the germination of turf species if overseeded too soon after application. Follow rates and intervals in the table below for best overseeding/reseeding results.
