DIRECTIONS FOR USE

Apply only to actively growing turf. Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn, and sweep any product that lands in the driveway, sidewalk, or street, back onto your lawn. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices. Check with your county or city government to determine if there are local regulations for fertilizer use.

Application Rates:

LOW RATE: 2.10 lbs./1,000 sq. ft.
MEDIUM RATE: 4.16 lbs./1,000 sq. ft.
HIGH RATE: 6.25 lbs./1,000 sq. ft.

For all applications:

- Apply to dry foliage
- Water in after application with a minimum of 0.2 inches to help move particle into the turf canopy.
- Do not collect clippings for at least one mowing following application to avoid particle pick-up

Cool Season Grasses:

- Apply at the MEDIUM RATE.
- Apply at the LOW RATE when temperatures exceed 85°F.

Warm Season Grasses:

- Apply at the MEDIUM or HIGH RATE every 4-6 weeks during the period of active growth.

Nitrogen Notice: For those states with nitrogen application restrictions, including but not limited to, MD, NH, NJ, PA, and VA, do not apply more than 0.9 lbs. of nitrogen per 1,000 sq. ft
