SECTION 11: TOXICOLOGICAL INFORMATION

HEALTH EFFECTS: May be irritating to the nose, throat, and respiratory tract, and may cause sore throat, coughing, and shortness of breath. Skin irritation may result. May also be irritating to the eyes, causing redness and watering. Prolonged eye exposure may cause conjunctivitis and corneal damage. Ingestion may result in sore throat, abdominal pain, nausea, and diarrhea. Ingestion of large amounts of sulfur may lead to hydrogen sulfide poisoning due to the bacterial conversion of sulfur in the colon.

CARCINOGENICITY: None of the ingredients are known / listed carcinogens. However, product may contain trace amounts of crystalline silica and inorganic fluorides. Fluorides have been suggested as a reproductive hazard and a carcinogen. Crystalline silica is listed by IARC as a potential human carcinogen.

INGREDIENT TOXICITY RANGES:

ORAL: > 2,000 mg/kg (diammonium phosphate) – 6,600 mg/kg (potassium sulfate)

DERMAL: > 5,000 mg/kg (diammonium phosphate)
