### Warm Season Grasses:

- Apply at the HIGH or HEAVY RATE every 4-6 weeks during the period of active growth.

Apply only to actively growing turf. Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn and sweep any product that lands on the driveway, sidewalk or street, back onto your lawn.
