DIRECTIONS FOR USE

SPREAD PRODUCT

Apply product to dry foliage. Fill and adjust your spreader to the recommended rate using the spreader settings table to the right. For even application, be sure to walk at a steady rate, slightly overlapping each pass. Lean & Green may have a cumulative effect. For best results, reapply every 4-6 weeks.

Apply only to actively growing turf. Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn and sweep any product that lands on the driveway, sidewalk or street, back onto your lawn. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices. Check with your county or city government to determine if there are local regulations for fertilizer use.

IMPORTANT! CLEAN-UP

This product contains iron sulfate and will stain. Sweep any product on driveways and sidewalks back onto your lawn. Do not wash with water. Return any unused material back into the original package.

WATER IN

To help move the particles into soil more quickly, water with a minimum of 0.2 inches.

SPREADER SETTINGS

Select the rate based on your desired response. The High rate will result in a greater response. Turf that is regularly fertilized may not experience as significant of a response, even at the High rate.

Settings are based on an average walking speed of 3 mph. Reduce setting for a lower speed; raise setting for a higher speed.
