CARCINOGENICITY: Trifluralin is not classifiable as to its carcinogenicity to humans (IARC Group 3). The product may contain trace amounts of crystalline silica which is listed by IARC as a potential human carcinogen.

INHALATION: > 2,800 mg/kg (trifluralin, 1h)
