SECTION 11: TOXICOLOGICAL INFORMATION

HEALTH EFFECTS: May be irritating to the nose and respiratory tract, and may cause sore throat, coughing and shortness of breath. Skin irritation may result from repeated or prolonged exposure. May also be irritating to the eyes, causing redness and watering. Ingestion may result in abdominal pain, nausea, diarrhea, vomiting, blurred vision, sweating, salivation, muscle twitching, and tremor. Ingestion of large amounts of sulfur may lead to hydrogen sulfide poisoning due to bacterial conversion of sulfur in the colon.

CARCINOGENICITY: None of the ingredients are known / listed carcinogens. However, the product may contain trace amounts of crystalline silica, which is listed by IARC as a potential human carcinogen. Oxadiazon has been shown to cause liver tumors at high doses. Oxadiazon is not teratogenic or mutagenic.

ORAL: 2,600 mg/kg (potassium chloride) – 14,300 mg/kg (urea)

DERMAL: > 2,000 mg/kg (oxadiazon)

INHALATION: > 1.8 mg/L (4 hr) (oxadiazon)
