The Andersons Core 24-6-12 contains micronutrients and iron for super-deep greening. The 24-6-12 formula is balanced to the ideal 4-1-2 ratio of nitrogen, phosphorus, and potassium making it the perfect all-purpose fertilizer. Core 24-6-12's fine particle size ensures more granules per square foot and a more even distribution of nutrients. It is beneficial for all turf types and can be applied at any time during the growing season. Quick and slow-release nitrogen sources provide fast results and continual feeding for up to 8 weeks.



DIRECTIONS FOR USE



SPREAD PRODUCT

Apply product to dry foliage. Fill and adjust your spreader to the recommended rate using the spreader settings table to the right. For even application, be sure to walk at a steady rate, slightly overlapping each pass.



CLEAN-UP

Sweep any product on driveways and sidewalks back onto your lawn. Return any unused material back into the original package. This product may stain. **Do not wash with water.**



WATER IN

To help move the particles into soil more quickly, water with a minimum of 0.2 inches.



STORAGE

Store left over product in a clean, dry place. Reseal opened bag by folding top down and securing.



PRO TIPS

- Mow before applying
- Do not apply prior to heavy rainfall to avoid particles getting washed away
- Do not collect clippings for a least one mowing to avoid particle pick-up
- Reapply every 6-8 weeks during the growing season

SPREADER SETTINGS

This bag is designed to deliver 2.9 lbs. of product per 1,000 sq. ft. at the Low Rate for a coverage of 15,500 sq. ft. and 4.2 lbs. of product per 1,000 sq. ft. at the High Rate for a coverage of 10,700 sq. ft. Settings are based on an average walking speed of 3 mph. Reduce setting for a lower speed; raise setting for higher speed.
