**PURPOSE:** Humic Acids may increase or enhance micronutrient uptake. Biochar is a carbon source structure for supporting soil microbiology. Microbials may improve nutrient release and efficiency.

### General Information

RejuvaSoil is an all-natural soil amendment containing humic acid, biochar, and beneficial microbes. Humic acid may increase nutrient and fertilizer efficiency while also increasing soil organic matter and soil carbon. Biochar provides increased soil carbon and improved nutrient holding capacity. Beneficial soil microbes in RejuvaSoil aide in restoring soil health.

## Turfgrass Application Directions

Apply at 3-5 lbs product per 1,000 sq ft (130-218 lbs per acre) using a properly calibrated rotary spreader. See application rate table for rates and spreader settings. Apply product to dry foliage. Water in after application. Reapplication interval will vary based on preexisting soil conditions. Product can be reapplied up to six times annually.

## Tree and Ornamental Application Directions

Apply at 4-5 lbs product per 1,000 sq ft using a properly calibrated rotary or handheld spreader. Apply prior to planting for annuals. If applying to existing plants, apply when plants are dry and then water in after application. Reapplication interval will vary based on growth/age of plant material and preexisting soil conditions. Product can be reapplied up to four times annually.
