DIRECTIONS FOR USE

TURFGRASS

Apply only as directed. For use on all turfgrasses. Apply any time during the growing season while turf is actively growing. Make application to dry turf. All applications should be watered immediately with 0.20 inches of water prior to any traffic to reduce potential for staining. Staining potential is greatest when applied at High Rate to nutrient-deficient turf. Avoid mowing soon after application. For best results when used on greens and other close cut turf, apply at aerification or grow-in.
