### DIRECTIONS FOR USE

Apply only as directed during the growing season. Apply when a regular feeding of nitrogen and potassium along with micronutrients is desired. DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED. APPLY THIS PRODUCT ONLY TO YOUR LAWN/GARDEN, AND SWEEP ANY PRODUCT THAT LANDS ON THE DRIVEWAY, SIDEWALK, OR STREET, BACK ONTO YOUR LAWN/GARDEN. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices. ### Warm Season Grasses:

- Apply at the MEDIUM RATE during the growing season.

### Storage and use:

Store in a clean, dry place. Reseal opened bag by folding top down and securing. Use only clean, dry spreaders. Do not leave unused product in spreaders.

**Notice:** This product contains the micronutrient iron for extra greening and to help prevent iron deficiency. Iron may stain concrete and other surfaces. Misapplied product to these surfaces should be removed promptly by sweeping or blowing. Do not wash off with water.
