First Aid

DIRECTIONS FOR USE

Apply first in early spring before weeds germinate and again in fall, both at the high preventative rate. Weed control efficacy is related to the application rate and weather conditions. Any weed present at application will not be controlled. Apply to dry turf using a broadcast spreader at suggested rates below and water in with 0.2" of irrigation within 1-2 days. Apply up to 4 times per year at the high rate.

Do not use at seeding. After seeding, wait 45 days to apply Grass Guard DG. No not apply for 60-90 days before seeding (rate dependent).

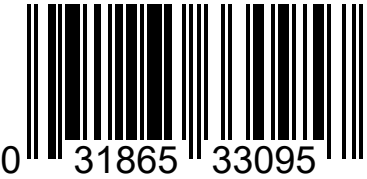
